If you are registering as a dual credit nondegree high school student you must complete and return this form to the <u>admissions office at the campus</u> where enrollment is planned. Students who have completed their junior year or are currently in their senior year of high school are eligible for dual credit enrollment. Exceptions for high school juniors and underclass students are considered on a case-by-case basis. Enrollment as a nondegree high school does not imply admission to the University. High School graduates must submit a formal application to be considered for admission as an undergraduate degree student.
